PRODUCT INFORMATION

Nitrolizer Duo is a dual-function product, that offers above and below ground protection for urea-based nitrogen fertilizer. Nitrolizer Duo is recommended for use urea and urea-ammonium nitrate (UAN) solution fertilizer. Nitrolizer Duo contains N-(n-butyl)thiophosphoric triamide (NBPT), a urease inhibitor to minimize ammonia volatility losses and Dicyandiamide (DCD), a nitrification inhibitor.

INGREDIENT: N-(n-butyl)thiophosphoric triamide (NBPT).....15%; Dicyandiamide (DCD).....15%

SUGGESTED USE RATE: Urea 46-0-0: 3.0 - 4.0 liters per tonne: UAN (28-32%): 2.0- 4.0 liters per tonne

DIRECTIONS FOR USE

Wear protective face, eyewear, clothing and gloves during the handling of Nitrolizer Duo and Nitrolizer Duo-blended urea and UAN solution. Nitrolizer Duo can be blended directly into UAN solution. Nitrolizer Duo can be blended in advance or just prior to application. If pre-blended in a storage tank, recirculate the tank before use. Urea blending: Use a fertilizer blender with impregnation equipment or its equivalent to uniformly coat the urea particles. Blend Nitrolizer Duo with urea, before the addition of other fertilizer components or additives. If blend appears wet, a drying agent may be added to the fertilizer mixture. Add drying agent at approximately 1 kliogram per tonne at a time. Add more as necessary. UAN Solutions: Fill spray tank haffway with UAN and add Nitrolizer Duo directly to the UAN solution and agitate. Allow agitation to continue while adding remainder of UAN until thoroughly mixed into an uniform solution. Nitrolizer Duo is believed to be compatible with most UAN and urea combinations. Not all possible combinations have been tested, and therefore a jar test is recommended before use.

STORAGE & DISPOSAL

Store product in original container tightly closed. Keep packaging closed, securely fastened, and upright. Do not store near heat or open flame. Do not reuse container. Do not allow product to freeze. In cold weather, this product may stratify or freeze. If this occurs, thaw and remix before using. Store above 45 F/7 C. Do not reuse this container for any purpose. This is a recyclable container and is to be disposed of at a container collection site. Contact your local distributor/dealer or municipality for the location of the nearest collection site. Before taking the container to the collection site in your area, dispose of the container. Add the rinsings to the spray mixture in the tank. 2.
