DIRECTIONS FOR USE

Wear protective face, evewear, clothing and gloves during the handling of Nitrolizer Duo and Nitrolizer Duo-blended urea and UAN solution. Nitrolizer Duo can be blended directly into UAN solution. Nitrolizer Duo can be blended in advance or just prior to application. If pre-blended in a storage tank, recirculate the tank before use. Urea blending: Use a fertilizer blender with impregnation equipment or its equivalent to uniformly coat the urea particles. Blend Nitrolizer Duo with urea, before the addition of other fertilizer components or additives. If blend appears wet, a drying agent may be added to the fertilizer mixture. Add drying agent at approximately 1 kilogram per tonne at a time. Add more as necessary. LAN Solutions: All sprav tank halfway with UAN and add Nitrolizer Duo directly to the UAN solution and agitate.
